Present:

Shady Hollow 4th of July Parade:

- Cyndi was notified that the HOA voted to hold the 4th of July Parade on Saturday, July 3rd. The swim team board will need to modify plans for the awards ceremony and the float decorating.
- Swim team board agreed that we still want the swim team to participate in the parade and that we still want the awards ceremony to include the ice cream social.
- We will attempt to find a venue for the Awards Ceremony to be conducted on Friday, July 2nd (probably 7:00 8:30 p.m.). Cyndi will confirm whether or not Baranoff Elementary will be available.
- We will plan on meeting at El Dorado and Sundown on Saturday, July 3rd at 8:30 a.m. to decorate the trailer's being used for the float. The parade begins at 10:00 a.m.
- Kenny Rice has agreed to drive/pull one of the two trailers. Another volunteer will be needed.
- We discussed the possibility of swimmers tossing out old spirit items, in addition to candy, throughout the parade route.

Circle C Meet:

- There were some issues at today's meet that were discussed. Among these issues were that
 only 2 judges were watching 5 lanes and incomplete DQ slips. The meet director had to throw
 out incomplete DQ slips. Reasons for incomplete DQ slips were discussed...the main reason
 seemed to be that there was not enough time to complete them properly due to the number of
 lanes each judge was watching.

League:
